(2) For purposes of these By-Laws, "Owner" shall mean and refer to (1) or more Persons who hold the record title or is the spouse of a Person who holds the record title to any Lot, but excluding in all cases any party holding an interest merely as security for the performance of an obligation. If a Lot is sold under a recorded contract of sale, and the contract specifically so provides, then the purchaser (rather than the fee owner) will be considered the Owner. As used herein, "person" means a natural person, a corporation, partnership, a trustee, or other legal entity..
